

#### How to register posted drivers in Poland?

Report the posting of a driver from a third country to the territory of Poland in 10 steps



2. Submit a driver posting notification to the National Labor Inspectorate. Prepare a notification on an interactive PDF form and send it online via the Biznes.gov.pl portal.




The driver posting notification should contain at least the following information: 1) name and address of the road carrier from a third country posting the driver to the territory of Poland; 2) the number of the relevant permit required for international road transport; 3) name and surname of the person designated for contacts with the authorities and authorized to represent the road transport operator from a third country posting the driver to the territory of Poland; 3) name, address and driving license number of the driver; 4) expected start and end dates of posting a driver from a third country to Poland; 5) the start date of the driver's employment contract the registration number of the motor vehicle used for the posted transport; 5) whether the transport services provided are carriage of goods, carriage of passengers, international carriage or cabotage.


